## **DIRECTIONS FOR USE**

To be used only in the manufacture of miticide products which are registered under the Pest Control Products Act.

**DO NOT** apply this product directly to freshwater habitats (such as lakes, rivers, sloughs, ponds, prairie potholes, creeks, marshes, streams, reservoirs, ditches and wetlands), estuaries or marine habitats.

**DO NOT** contaminate irrigation or drinking water supplies or aquatic habitats by cleaning of equipment or disposal of wastes.

**DO NOT** discharge effluent containing this product into sewer systems, lakes, streams, ponds, estuaries, oceans or other waters.

## **PRECAUTIONS**

### **PREVENT ACCESS BY UNAUTHORIZED PERSONNEL**

Harmful if inhaled. Avoid breathing vapours or spray mist. Avoid contact with skin, eyes and clothing. Wash concentrate from skin or eyes immediately. When handling the concentrate wear chemical resistant gloves, a long sleeved shirt and long pants. Do not inhale fumes. Avoid breathing vapors or spray mist. After use, wash hands and other exposed skin, before eating, drinking or smoking. Remove and launder contaminated clothing separately from household laundry before reuse. Do not contaminate feed or food. Keep unprotected persons out of the operating area. If an accident occurs, remove contaminated clothing and wash skin thoroughly with soap and water. **DO NOT** discharge effluent containing this product into sewer systems, lakes, streams, ponds, estuaries, oceans or other waters.

### **FIRST AID**

Remove person from contaminated area; remove contaminated clothing. Keep patient warm, comfortable, and at rest.

**If in eyes**, hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

**If on skin or clothing**, take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice.

**If inhaled**, move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

**If swallowed**, call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.
