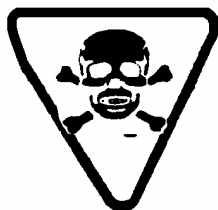

FIRST AID

Take container, label or product name and Pest Control Product Registration number with you when seeking medical attention.
