#### DIRECTIONS FOR USE:

To be used only in the manufacture of a herbicide which is registered under the *Pest Control Products Act*.

#### PRECAUTIONS:

**PREVENT ACCESS BY UNAUTHORIZED PERSONNEL.** Avoid contact. Avoid breathing technical dust or fumes. Wash thoroughly after using or before eating or smoking. Wear protective clothing including goggles and respirator when handling the product.

#### FIRST AID:

**IF INHALED:** Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.
