PRECAUTIONS:

PREVENT ACCESS BY UNAUTHORIZED PERSONNEL

Concentrate is harmful or fatal if swallowed or inhaled. Corrosive. Causes irreversible eye damage and severe skin burns. Potential skin sensitizer.

Do not get in eyes, on skin or on clothing.

Wear full-face protection, coveralls, and chemical-resistant boots when handling the concentrate or dilute solution, when opening treating cylinder doors and during cleaning, maintenance and repair activities on storage vessels or treating cylinders. In addition, wear a cartridge respirator when handling the concentrate or the dilute solution if the area is not well ventilated, when opening treating cylinder doors and during cleaning, maintenance and repair activities on storage vessels or treating cylinders. Wear coveralls and gloves when handling freshly treated wood. Wash hands and face before eating, drinking, smoking and using the toilet. Change clothing daily. Wash contaminated clothing separately from household laundry.

FIRST AID:

IF IN EYES: Hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

IF ON SKIN OR CLOTHING: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice.

IF INHALED: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

IF SWALLOWED: Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

Take the container label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION:
